"We will always remember and honor the indomitable will of Deputy U.S. Marshal Wells, for his heroic sacrifice and his unwavering commitment to protecting the American citizenry," stated Jon Adler, FLEOA National President.

"The profound loss of our brother is beyond measure, but his willingness to risk his own life in the pursuit of homicidal maniacs is his legacy to all of us.
